This meet will be swum as Short Course yards (SCY)

Eligibility: Only swimmers who have a **current USMS 2012** registration will be allowed to compete. Registration is available online at <http://www.usms.org/reg> **Enclose a photocopy of your USMS membership card with your entry.**

Entries: Pre-entries are \$28; pre-entries should be postmarked by January 11th. Deck entries on the morning of the meet will be \$45. All relays will be deck entered. Swimmers may swim a maximum of 5 individual events and 3 relays.

Warm-up will begin at 8AM, the meet will begin at 9AM. Enter the pool feet first; no diving is allowed during warm-up except in the designated "diving" lane.

The 1000 yd Freestyle may be swum in two pools, all other events will be swum in a single pool. No deck entries will be accepted for the 1000 yd Freestyle.

Location: Jones Natatorium at Eastern Michigan University, which is located in the Athletic Campus (see attached map)

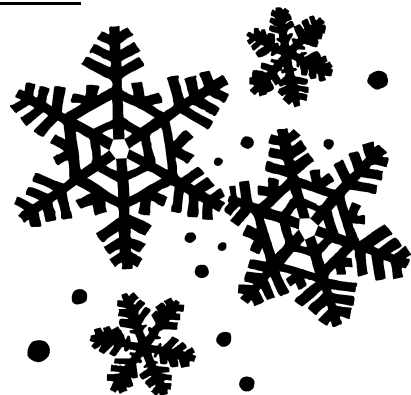

EMU State Meet Map

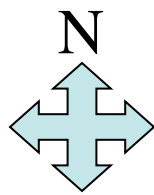
