The Grand Haven Pool is 10 years old. It features 8 lanes, continuous warm-up area, Colorado timing, and large spectator area. Parking is free.

Deck Registration 9:15 a.m. - 11:15 a.m. (but event #1 cuts off registration at 9:45 a.m., and events 2&3 cuts off at 10:15 a.m.).

1650/1000 Free starts at 10:15 a.m.

Warm-ups are 9:30 - 10:00 a.m. and after event #3 the 200 Fly.

Event 4 should start at approximately 12:00 Noon.

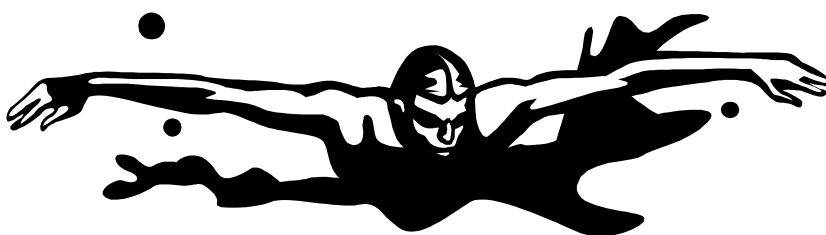
All heats seeded slow to fast. Limit of 5 individual events plus 1 relay per swimmer.
