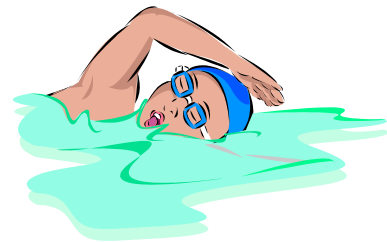


Woodhaven High School Presents 2008 Masters 2nd Annual “Autumn Aqua Challenge”

Woodhaven High School is approximately 20 minutes south of Detroit.
We are also in close proximity to Ann Arbor, Monroe, & Toledo.
- Facility: Woodhaven High School has a 6-lane 25 yd. pool. Lane 1 will be a continuous warm-up/cool down lane during the meet. Parking will be on the east side of the building. Lockers will be available. Please provide your own lock, as we cannot be responsible for any lost or stolen items.
- Eligibility: Participants must be registered with USMS. Each swimmer is responsible for his/her USMS card and will be required to show it upon request by officials. To enter the meet, a copy of the swimmer's current USMS registration card MUST accompany the entry form. Registration materials are available at <http://registration.usms.org>.
- Times: Warm-Up: 8:00 A.M. Meet Starts at 9:00
- Entry Fee: \$20 per person if received before November 20th. Day of registration will cost \$25. We will stop accepting deck entries at 8:15 a.m. Proceeds will go to support the high school boys and girls swim programs. Make checks payable to Woodhaven High School. Swimmers may enter a maximum of (4) events and (2) relays. A light meal will be provided after the meet.
